

SUMMARY ANNUAL REPORT

For Central Texas College Employees' Supplemental Plan and Trust

This is a summary of the annual report for Central Texas College Employees' Supplemental Plan and Trust, EIN 74-1539003, Plan No.003, for period September 01, 2014 through August 31, 2015. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by insurance and a trust fund. Plan expenses were \$1,418,322. These expenses included \$121,397 in administrative expenses, and \$1,296,925 in benefits paid to participants and beneficiaries. A total of 3,430 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$10,142,936 as of August 31, 2015, compared to \$11,133,009 as of September 01, 2014. During the plan year the plan experienced a decrease in its net assets of \$990,073. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$428,249, including employer contributions of \$268,039, employee contributions of \$268,039, earnings from investments of (\$176,155), and other income of \$68,326.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
