34	Refunds of Tuition and Fees	Added the following sentence after the first sentence in the section: The college is under no obligation to refund tuition and fees, or other costs associated with a student who is administratively withdrawn.
54	Administrative Initiated Withdrawals	Replaced the last paragraph after the bulleted items with the following: Refer to the CTC refund policy in the College Costs section of this catalog as it relates to administrative withdrawals.

5	College Calendar	Changed start date of Summer I and 10 Week Classes to May 31. Changed Final Exams (Summer I) to July 3. Changed start date of Summer II to July 5. Changed Final Exams (10 Week and Summer II) to August 7. Changed Graduation to August 5. Added Juneteenth Holiday June 20.
5	General Information, The Catalog	Last sentence of first paragraph was changed to: The associated Deputy Chancellor of Central Texas College has the authority to override institutional policies in this Catalog for certain exceptions when warranted.
15	TSI Exemptions and Waivers	Item 13 HiSET, third and fourth sentences were corrected grammatically to: The test exemption is effective May 12, 2021, and test scores are valid for five (5) years from date of testing. However, the HiSET scores with test administration dates after August 31, 2021, will no longer be useable for the TSI exemption (the Texas Education Agency will no longer administer the test after 8/31/2021). And in the last sentence of same section HSE was changed to HiSET.
15-16	Waivers	Corrected numbers under Waivers to be sequential from preceding section starting with #12 changed to #14 and ending with #26 changed to #28.
32	College Costs, Tuition Schedule for 2021-2022	Added the differential tuition per credit hour: MSSG \$35 effective March 2022.
39	Student Financial Assistance, Financial Aid Programs	Deleted the Selective Service Registration Compliance section in its entirety
39	Eligibility Requirements for Financial Aid	Deleted the bullet item: Is registered with the selective service if required to do so.
