ORDER OF ELECTION
(IAW Texas Election Code Section 3.006)**

**STATE OF TEXAS:
COUNTIES OF BELL AND CORYELL**

WHEREAS, this Board of Trustees deems it advisable to call the election hereinafter ordered for the purpose of electing a representative to the following positions:

Board Trustee Place 4(6-year term)

Board Trustee Place 5(6-year term)

WHEREAS, it is hereby officially found and determined that holding hereafter called election on a uniform election date established by Section 41.001(a), Texas Election Code, is in the public interest; and that this was determined in a meeting open to the public for which public notice with time, place, and purpose of said meeting was given, all as required by the Texas Government Code 551.

**THEREFORE, BE IT ORDERED BY THE BOARD OF TRUSTEES OF THE
CENTRAL TEXAS COLLEGE DISTRICT:**

1. That an election shall be held between the hours of 7:00A.M. and 7:00P.M. on May 1, 2021 in said District at the regular election precincts of said District, at regular polling places are as follows:

Precinct #101 and #111, Nolanville Community Center, 408 North 10th Street, Nolanville, Texas including all or part of Bell County Precinct Nos. 101 and 111, which lie within the boundaries of the District.

Precinct #106, Transforming Life Fellowship, 4107 Westcliff Road, Killeen, Texas including all or part of Bell County Precinct No. 106, which lies within the boundaries of the District.

Precinct #109, St Joseph's Catholic Church, 2903 E. Rancier Ave, Killeen, Texas including all or part of Bell County Precinct No. 109 which lies within the boundaries of the District.

Precinct #201 and #204, Fire Station #3, 700 Twin Creek Drive, Killeen, Texas including all or part of Bell County Precinct Nos. 201 and 204, which lie within the boundaries of the District.

Precinct #205, Jackson Professional Learning Center, 902 Rev. R.A. Abercrombie Drive, Killeen, Texas including all or part of Bell County Precinct No. 205, which lies within the boundaries of the District.

Precincts #206, #402 and #409, Killeen Senior Center, 1700 E. Stan Schlueter Loop, Killeen, Texas including all or part of Bell County Precinct No. 206, #402 and #409, which lie within the boundaries of the District.

Precinct #207, Copper Mountain Branch Library, 3000 South W. S. Young Drive, Killeen, Texas including all or part of Bell County Precinct No. 207, which lies within the boundaries of the District.

Precincts #208 and #210, Cedar Valley Elementary School, 4801 Chantz Drive, Killeen, Texas including all or part of Bell County Precincts Nos. 208 and 210, which lie within the boundaries of the District.

Precincts #201, #202, #209 and #111, Harker Heights Recreation Center, 307 Miller's Crossing, Harker Heights, Texas including all or part of Bell County Precinct Nos. 201, 202, 209, and 111, which lie within the boundaries of the District.

Precincts #401, #407, #412 and #413, Haynes Elementary School, 3309 W. Canadian River Loop, Killeen, Texas, including all or part of Bell County Precinct Nos. 401, 407, 412 and 413, which lie within the boundaries of the District.

Precincts #404, #110 and Coryell Precincts #206 and #311, Killeen Fire Station #7, 3701 Watercrest Road, Killeen, Texas including all or part of Bell County Precinct Nos. 404, 110 and Coryell County Precincts, 206 and 311, which lie within the boundaries of the District.

Precinct #405, Robert M. Shoemaker High School, 3302 Clear Creek Road, Killeen, Texas including all or part of Bell County Precinct No. 405, which lie within the boundaries of the District.

Precinct #406, Central Fire Station, 201 N. 28th Street, Killeen, Texas including all or part of Bell County Precinct No. 406, which lies within the boundaries of the District.

Precinct #408, Killeen Fire Station #5, 905 Jasper Drive, Killeen, Texas including all or part of Bell County Precinct No. 408, which lies within the boundaries of the District.

Precinct #410, Fire Department Support Facility, 114 West Ave D., Killeen, Texas including all or part of Bell County Precinct No. 410, which lies within the boundaries of the District.

Coryell County Precincts #101, #104, #206, #207, #412, #416, Coryell County Early Voting Center; 508 B. Cove Terrace Street, Copperas Cove, Texas including all or part of Coryell County Precinct Nos. 101, 104, 206, 207, 412, 416, 408, which lie within the boundaries of the District.

2. That the Presiding Judge shall appoint not less than two or more than four qualified election clerks to serve and assist in conducting said election; provided that if the Presiding Judge actually serves as expected, the Alternate Presiding Judge shall be one of such clerks.

3. That early voting by personal appearance shall also be conducted at Permanent Branch Early Voting locations established with the respective City Halls which lie within the boundaries of the District as listed below for residents of those cities and also at the Killeen ISD Central Administration Building, 200 North W.S. Young, Killeen, Texas 76543, during the period early voting is required and permitted by law, being April 19, 2021 through April 27, 2021, and during the hours designated for early voting by personal appearance shall be from 8:00A.M. to 5:00 P.M. on each day except Saturdays, Sundays, and official state holidays; and the Early Voting Clerk shall keep said Main Early Voting Place open during such hours for early voting by personal appearance.

Lions Park Senior Center, 1700-B East Stan Schlueter Loop

Harker Heights: Harker Heights Parks & Recreation Center, 307 Miller's Crossing




4. That all resident qualified electors of said District shall be entitled to vote at said election.
5. That the first day for requests for applications for an early voting ballot by mail to be received shall be January 1, 2021. The last day for requests for applications for an early voting ballot by mail to be received shall be April 20, 2021. Requests for ballot applications to be voted by mail may be made in person at the Central Texas College Administration Building, 6200 W. Central Texas Expressway, Killeen, Texas 76549 or mailed to the Early Voting Clerk, Central Texas College, P.O. 1800, Killeen, TX 76540.
7. That a substantial copy of the Order shall serve as proper *Notice* of said election, and the Chair of the Board of Trustees shall cause said Notice to be published one time, not earlier than the 30th day or later than the 10th day prior to the date of the election, in the newspaper published in said District. In addition, not later than the 21st day prior to the date set for the election, the Chair of the Board of Trustees shall cause said Notice to be posted on the bulletin board used for posting notices of meetings of the Board of Trustees.






