Old Business:	<ul style="list-style-type: none"> • Recommended replacing the Shotgun Qualification portion of the Academy with Patrol Rifle Operator Course in BPOC <ul style="list-style-type: none"> ○ The shotgun is becoming obsolete in most Police Departments ○ TCOLE has increased the Academy hours to 720 so the extra course can be added easily ○ The Academy has the resources to put the Cadets through the course ○ Recommended Approval by Albert Miceli, 2nd by Chief Wilson, the decision was approved unanimously • Revision of the Cadet Handbook <ul style="list-style-type: none"> ○ Chief Wilson worked on reformatting the Cadet Handbook ○ Discussion was had on the Physical Readiness portion of the Handbook <ul style="list-style-type: none"> ▪ The Academy is still using the 25% VO2 Max ▪ Most of the applicants are reaching the 25% during the entry process ▪ The 25% was mandatory before, but the previous board voted to make it optional ▪ Discussion was had on changing the wording from “must complete and achieve that percent” in the handbook to “should” ▪ Discussion was had on the difference between having the 25% on enrolling in the Academy, and the difference of what is expected on the Physical Expectations during the Academy and adding in the


handbook that the VO2 max will be a performance test for a grade

- Recommendation was made to separate the Physical Training and the VO2 Max into two paragraphs for clarity in the handbook
- Discussion was had on the Weapons section of the Handbook
 - Recommended removing the word “knife” from “possession of any prohibited or illegal knife weapon during any Academy related function...” because there are no prohibited knives in the State of Texas anymore, just location restrictions
- Discussion was had on the Dismal from the Academy portion of the Handbook
 - There has been a lot of revision from the old handbook to where the new handbook is, and the appeal process
 - Discussion was had on if a Cadet is dismissed and the appeal is upheld, is it fair to punish the Cadet if they missed practical portions of the Academy and cannot make it up due to time factors, or in another Academy class or if TCOLE approval is needed
 - Decided to reach out to TCOLE for clarification and instruction on this matter
 - Adding a Review Board for cases of the Appeal Process
- Discussion was had on Shaving Profiles and beards in the Academy
 - Decision was made to table to the next meeting while looking into how other Departments are addressing the issue
- The Academy received new equipment with the Perkins Grant
 - Glock and Smith & Wesson Red Guns
 - 10 SIRT Guns
 - 9 mm and .223 ammo for instructions
 - Stream Flashlights
 - Dummy rounds for the 9 mm and 40 cal
 - Radios are on backorder
- TCOLE preformed an Audit this year and there was no Deficiencies
- The College Comptroller has inquired about increasing the cost of the Academy for the Sponsored Cadets to the same as Non-Sponsored Cadets. We recommended not increasing the rate.
- Ms. Jouett will be leaving, Mr. Greenwood will be replacing her on the Advisory Board
- Motion was made to approve the revision to the Handbook with the amendments mentioned by Chief Wilson, 2nd by Mr. Miceli, motion passed unanimously

New Business:

- The question was raised if there has been any concern on acquiring ammo for the new Patrol Rifle portion of the Academy – nobody has voiced any concern as of yet. The academy has enough rifles to handle the current class load.
- Twenty-six cadets from BPOC Alpha and Delta took the TCOLE Exam on Dec 1, 2023. Fourteen passed on their first attempt and twelve failed their first attempt. Eleven of the twelve that failed their first attempt has taken and passed the TCOLE exam. The remaining cadet failed the TCOLE exam on his second attempt. He has not made his final attempt yet.
 - The Academy is supporting that cadet by having the Instructor reach out to him and put him in touch with other students to help him study
- What affects the Academy is the first attempt pass rate, on a three-year basis with TCOLE. We have to maintain an 80% or better.
- To improve our pass rate, we will do the following:
 1. Use the TCOLE analysis to identify problem areas
 2. Future classes will be required to take weekly comprehensive exams
 3. Staff is updating exams with new questions
- We started BPOC Bravo with 35 cadets
 - One cadet was arrested the first week for family violence
 - One cadet has transferred to the Night Academy
 - Another cadet has withdrawn from BPOC Bravo and is considering applying to the night class
 - Three cadets have failed the first or second exam three times and was dismissed from the Academy
- We are not supposed to go over 30 cadets. We accepted 7 independent cadets before we realized that we had a higher than usual number of sponsored cadets. When we realized that we would go over 30 cadets we stopped accepting independent cadets. We did not turn away any agencies that were trying to send us cadets. - The cadet that was dismissed for discipline appealed his dismissal. The cadet was dismissed because he failed to document that he was involved in a domestic where he pointed a loaded gun at his brother. He appealed his dismissal to the appeal board we approved at the last board meeting. Deputy Chief Alber voiced a concern that we do not perform background checks on our cadets.
 - We researched a company out of Houston that can provide this service for us at \$600.00 a person. They would not do face to face visits. If the board insist that we have background checks done, I recommend that we use this service or not accept independent cadets.
 - There was discussion on if the cost of the background check could be built into the cost of tuition, or have it as an upfront cost directly to the Cadet
 - We also recommend that the faculty member chosen for the disciplinary board not be from the Protective Services Department.
 - Recommendation was made for Police Academy Staff to not be present for the discussions from the Appeal Board, to be able for questions if needed
 - Changes for the Appeals Process will be updated in the Cadet Handbook
- We were approved to purchase the following with Perkins funds:
 - Hand Held Breathalyzers
 - 15 Glock 45 – 9mm pistols
 - Red dot sights for pistols
 - Focus will still be on the basic of using firearms with the iron sights first
 - Suggestion was made to add that we require an iron sight so it can be co-witnessed if the Cadet's optics goes out

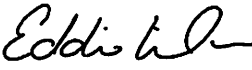

<p>New Business:</p>	<ul style="list-style-type: none"> ● Nineteen cadets from BPOC Charlie 2023 graduated on Sept. 22, 2023. Seventeen passed the TCOLE exam on their first attempt. The remaining two passed the TCOLE exam on their second attempt.

- Lt. Osborne had the class analysis which breaks it down by Units, which will be sent out by email to the Board Members
- BPOC Alpha started with eight cadets. One was dismissed for possessing alcohol on campus.
- BPOC Delta began with 24 cadets. One was dismissed for failing to meet academic standards.
 - The Academy has made a lot of changes to in the way the classes are delivered and it has been having a big impact, scores are going up
- TCOLE announced they would require academies to teach an additional 16 hours for ALERRT training starting Jan 1, 2024. Central Texas College does not have a certified trainer for ALERRT. We are trying to locate a class to send instructors to but have not found one yet. TCOLE has not updated its website to reflect this. Lt. Osborne will try to obtain additional information when he attends the TCOLE conference next week.
 - To accommodate the new hours, the Academy will be extended by one week
 - Additional classes can be adjusted to accommodate any extra hours where needed
- The breathalyzers, Glock 45, and red dot sights from the Perkins grant came in.
- Our current policy requires any cadet dismissed for academic reasons to wait one calendar year to reapply. I want to remove the waiting period and allow them to reapply at the next available academy.
 - Lt. Osborne gave an example concerning a Cadet in the Day Academy that failed Unit 1 twice and decided to move to the Night Academy and is now one of the top academic Cadets in that class. Lt. Osborne feels the one year requirement is not necessary
 - Chief Wilson asked about the history of the one year waiting period, Lt. Osborne stated it was before his time
 - The criteria for dismissal for academics was reviewed for the Board
 - Mr. Miceli attended the Police Academy for Unit 1 with the Delta Class. He provided constructive feedback and recommendations for enhancing the learning experience of the class which seems to be making a big difference
 - Lt. Osborne stated the biggest change is they are requiring the Cadets to take review test every unit and it is really bringing their scores up
 - Lt. Osborne brought up how certain situations, i.e. illness or death in the family can impact their grades and if they can come back, they have a better understanding of what is required of them
 - Chief Wilson motioned to remove the one year waiting period to reapply after being dismissed for academic reasons. Mr. Donovan moved to remove the one year requirement. Ms. Groothoff seconded, the motion passed unanimously.
